



04. The employees governed under GIA order, 2017 are entitled to avail Dearness Allowance as admissible from time to time as accepted by Government in Higher Education Department for Non-Government College Employees.
05. The amount required for payment of current GIA salary shall be met out from the Budget provision of the Current Financial Year, 2018-19.
06. The present approval is subject to the condition that if at any subsequent stage anything is found incorrect / false / concealing of facts in connection with the incumbent concerned, the benefit of Grant-in-Aid as per the Grant-in-Aid Order, 2017 shall be withdrawn. The Governing Body of the concerned Educational Agency / Principal-Cum-Secretary shall also be liable to refund the amount received by him / her within a stipulated time and in case of failure to refund, the same shall be recovered as per the provisions of Odisha Public Demands Recovery Act, 1962.


