MEMORANDUM OF UNDERSTANDING (MOU)

This Memorandum of Understanding entered into this day of 30th December 2020.

BETWEEN

Department of Odia of Remuna Degree College, At- Srikrushnapur, Po-Remuna, Dist-Balasore, 756019, Odisha represented by the Principal, Mrs. Jayanti Nayak, aged about 46 years, First party.

AND

Department of Odia of Swarna Chuda Degree College, Mitrapur, Dist-Balasore-756020, Odisha represented by the Principal, Dr. Sarata Chandra Panigrahi, aged about 59 years, second party.

Where as both the parties are Degree Colleges in the District of Balasore got recognition as a Degree College by the Department of Higher Education, Government of Odisha being affiliated to the Fakir Mohan University, Balasore. Remuna Degree College has been included under accredited with 'B++' by NAAC and The Department of Odia was established in the year 1996. The College is functioning on its present campus at Remuna under Remuna Block. The second party Swarna Chuda Degree College, Mitrapur has been included under accredited with 'C++' by NAAC and the Department of Odia was established in the year 1983. The College is functioning on its present campus at Mitrapur Under Nilgiri Block.

The purpose of this agreement is to create an environment for development of Education in Odia Language and Literature.



Objectives

The goal is to foster collaboration, provide opportunity for global experience, and to facilitate advancement of knowledge on the basis of reciprocity, best effort mutual benefit and frequent interaction between the Department of ODIA Remuna Degree College and Swarna Chuda Degree College Mitrapur agree:

- a) To exchange information on teaching, learning and other literature to their educational and research programs.
- b) To exchange, on a reciprocal basis students at undergraduate level for purpose of education.
- c) To jointly organize seminar, workshops on topics of mutual interest and to invite each other faculty to participate therein.
- d) To encourage collaboration between faculty to participate in development programs.

Entry into force Duration and Termination

- 1. The MOU shall enter into force on the date of signing.
- 2. This MOU shall remain in force for a period of five (5) years and may be extended for another period of five (5) years by mutual written consent of the parties.
- 3. Either parties may terminate this MOU at any time by giving written notification to the other party on its intention to terminate this MOU six (6) month prior to the date of the termination.
- 4. It may be modified by written mutual consent of both parties.

This MOU was signed at Academy of Business Administration, a Professional College at Harida,Kuruda, Balasore on the 7th January 2014 between Mrs. Jayanti Nayak, Principal Remuna Degree College, Remuna, Balasore and Prof.Kamalakanta Acharya, Dean,, Academy of Business Administration, Kuruda,Balasore.

The general objective of this Memorandum of Understanding (MOU) is to stimulate and facilitate the development of collaborative and mutual beneficial programmes which serve to enhance the intellectual life and cultural development of both the campuses and to contribute to increased institutional cooperation for quality assurance. Thus Remuna Degree College, Remuna and Academy of Business Administration(ABA), Kuruda,Balasore agreed that in support of their mutual interest in the field of education and research:


1. The educational institutions will cooperate for the exchange of information relating to their activities in teaching and research in fields of mutual interests such as-
 - a) Curriculum enrichment
 - b) Faculty exchange and professional development
 - c) Research and consultancy
 - d) Career Counselling
 - e) Introduction of new courses
 - f) Student exchange
 - g) Conduct of cultural projects
 - h) Conduct of study tours



2. Both the institutions shall endeavour to facilitate exchange of students. The academic standings of such students shall be determined by both the institutions where necessary. Exchange of students will be accorded the rights and privileges of students in both the institutions under appropriate terms and conditions.
3. Admission to a specific department or course is subject to a student being satisfactorily qualified for the chosen area of study and to the availability of resources.
4. The aim of this memorandum of understanding shall be to achieve a broad balance in the respective contributions and benefits of the collaboration, and this shall be subject to periodic review by both the institutions.
5. Academic members of staff and other personnel of one partner institution may spend periods in other partner institution. In supporting such an arrangement, the home institution undertakes to continue the honorarium where applicable. All other financial matters including travel costs are subject to individual negotiation, and will normally be the responsibility of the persons involved and their home institution.
6. Both the institutions agree to assist in the seeking of appropriate housing and to supply workspace, library and technical facilities as appropriate.
7. In the implementation of specific cooperative programs, a written agreement covering all relevant aspects including funding and the obligations to be undertaken by each party will be negotiated, mutually agreed and formalized in writing prior to the commencement of the program.

This agreement will take effect from the date of its signing and shall be valid for an unlimited period from that date unless sooner terminated, revoked of, modified by mutual written agreement between both the parties.

Either party may terminate the agreement at any time during the term by the provision of three months written notice to the other party.
