BETWEEN

Department of History of Remuna Degree College, At- Srikrushnapur, Po-Remuna, Dist-Balasore, 756019, Odisha represented by the Principal, Mrs. Jayanti Nayak, aged about 46 years, First party.

AND

Department of History of Swarnachuda College At-Mitrapur, Po-Mitrapur, Dist-Balasore-756020, Odisha represented by the Principal, Dr. Sarat Chandra Panigrahi, aged about 59 years, second party.

Whereas both the parties are Degree Colleges in the District of Balasore. Remuna Degree College got recognition as a Degree College by the Department of Higher Education Government of Odisha being affiliated to the Utkal University, Bhubaneswar in 1996 and next to the North Odisha University, Myurbhanj in 1998 and finally to the Fakir Mohan University, Balasore in 1999. The College has been included under accredited with B++ by NAAC. The History Department was established in the year 1996. The College is functioning on its present campus at Remuna under Remuna Block. Whereas the second party Swarnachuda College got recognition by the Department of Higher Education Government of Odisha being affiliated to the Utkal University, Bhubaneswar in 1983. The College has been included under accredited with C++ by NAAC. The History Department was established in the year 1991-1992. The College is functioning on its present campus at Mitrapur under Nilgiri Subdivision.

The purpose of agreement is to create environment for development of History Education.

Objectives

The goal is to foster collaboration, provide opportunity for global experience, and to facilitate advancement of knowledge on the basis of reciprocity, Remuna Degree College and Swarnachuda College, Mitrapur, agree:

- a) To exchange information on teaching, learning and other literature to their educational and research programs.
- b) To exchange, on a reciprocal basis students at undergraduate level for purpose of education.
- c) To jointly organize seminar, workshops on topics of mutual interest and to invite each other faculty to participate therein.
- d) To encourage collaboration between faculty to participate in development programs.

Entry into force Duration and Termination

- 1. The MOU shall enter into force on the date of signing.
- 2. This MOU shall remain in force for a period of five (5) years and may be extended for another period of five (5) years by mutual written consent of the parties.
- 3. Either parties may terminate this MOU at any time by giving written notification to the other party on its intention to terminate this MOU six (6) month prior to the date of the termination.
- 4. It may be modified by written mutual consent of both parties.
