MEMORANDUM OF UNDERSTANDING (MOU)

This Memorandum of Understanding entered into this day of 29th December 2020 .

BETWEEN

Department of Mathematics of Remuna Degree College, At- Srikrushnapur, Po-Remuna, Dist-Balasore, 756019, Odisha represented by the Principal, Mrs. Jayanti Nayak, aged about 46 years, First party.

AND

Department of Mathematics of Swarna Chuda Degree College Mitrapur, Dist-Balasore-756020, Odisha represented by the Principal, Dr. Sarata Chandra Panigrahi, aged about 59 years, second party.

Whereas both the parties are Degree Colleges in the District of Balasore got recognition as a Degree College by the Department of Higher Education, Government of Odisha being affiliated to the Fakir Mohan University, Balasore. Remuna Degree College has been included under accredited with 'B++' by NAAC and The Department of Mathematics was established in the year 2016-17. The College is functioning on its present campus at Remuna under Remuna Block. Whereas the second party Swarna Chuda Degree College Mitrapur has been included under accredited with 'C+' by NAAC and the Department of Mathematics was established in the year 2017-18. The College is functioning on its present campus at Mitrapur Under Nilgiri Block.

The purpose of this agreement is to create environment for development of Education in Mathematics.

Objectives

The goal is to foster collaboration, provide opportunity for global experience, and to facilitate advancement of knowledge on the basis of reciprocity, Remuna Degree College and Swarna Chuda Degree College Mitrapur agree:

- a) To exchange information on teaching, learning and other literature to their educational and research programs.
- b) To exchange, on a reciprocal basis students at undergraduate level for purpose of education.
- c) To jointly organize seminar, workshops on topics of mutual interest and to invite each other faculty to participate therein.
- d) To encourage collaboration between faculty to participate in development programs.

Entry into force Duration and Termination

1. The MOU shall enter into force on the date of signing.
2. This MOU shall remain in force for a period of five (5) years and may be extended for another period of five (5) years by mutual written consent of the parties.
3. Either parties may terminate this MOU at any time by giving written notification to the other party on its intention to terminate this MOU six (6) month prior to the date of the termination.
4. It may be modified by written mutual consent of both parties.

In presence of witness the parties here to put their respective signatures on the day and date on the above mentioned after knowing the contents to be true and correct and binding on them.

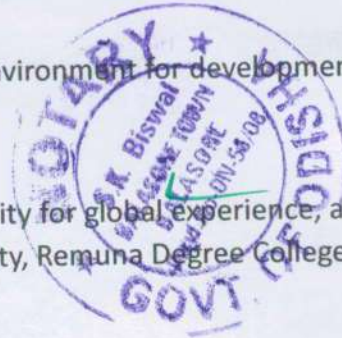
