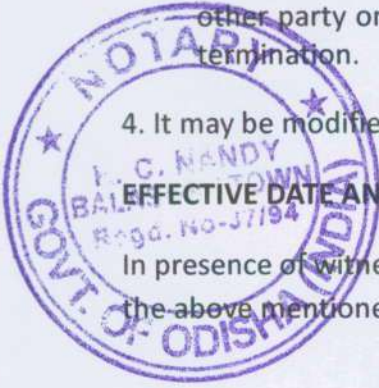
- To exchange information on teaching, learning and other literature to their educational and research programs.
